### Preliminary Meeting

January 13-14, 1968 - Geneva, Switzerland

*"Ad hoc committee evaluated conversations held in Europe and North America; recommendation to set up a permanent Lutheran-Reformed Committee whose main task was to further the theological consensus between Lutheran and Reformed Churches and to seek ways and means of achieving a closer working relationship between the two world families"*

"New committee named: scope was to examine the theological and ecclesiastical implications of the Leuenberg agreement; to undertake a series of case studies on Lutheran-Reformed relations; to continue studying the idea of a 'Universal Council'" - REPORT

March 29-30, 1979 -Geneva, Switzerland

"Consultation on the future of the dialogue where the Joint committee was dissolved and an ad hoc working group formed to consider the future of the full L/R Joint Committee"

September 2- 8, 1979 - Geneva, Switzerland

"Decision taken on the future of the dialogue"

August 2-8, 1981 - Wuppertal, Germany

"Report of the Ad hoc committee received by the LWF and the WARC encouraging further bilateral conversations"
