To enter the Centro Pro Unione you must follow the COVID protocol, established by the Administration on the basis of Italian law.

At the entrance, one of the following documents must be presented:

1. Green Pass
2. Vaccine card issued by the health authorities of Canada, Japan, Israel, United Kingdom of Great Britain and Northern Ireland (including Gibraltar, Isle of Man, Channel Islands and British bases on the island of Cyprus and excluding non-belonging territories to the European continent) and the United States of America
3. Evidence of recovery from COVID-19 within the past 6 months
4. Negative COVID test in the last 48 hours
